SHINE LINK VENTURE LIMITED is wholly owned by J&H Trust and the trust deed in respect of J&H Trust provides that Trident Trust company (HK) Limited, as the trustee, shall be entitled to exercise the voting rights attached to the ordinary shares held by SHINE LINK VENTURE LIMITED. None of the persons who have dispositive powers in respect of the ordinary shares held by SHINE LINK VENTURE LIMITED beneficially own more than 5% of the ordinary shares of the Company.

Percentage of aggregate voting power is calculated by dividing the voting power beneficially owned by such reporting person by the voting power of all of the Company's Class A ordinary shares and Class B ordinary shares as a single class. Each Class B ordinary share is entitled to ten votes per share, whereas each Class A ordinary share is entitled to one vote per share.
